Dear Licensee,

All licensed individuals and companies that intend to operate and do business in Kern County are required to register on an annual basis with the Department of Agriculture and Measurement Standards. All **2015** registrations expire December 31, 2015. Before performing any work in Kern County for calendar year **2016**, you must first be registered for that calendar year.

Hours for registration will be Monday through Friday, 8:15 a.m. to 11:30 a.m. and 1:15 p.m. to 4:30 p.m. We are sorry, but no one will be available between 12:00 noon and 1:00 p.m. to complete your registration.

Please be sure you bring the following items with you at time of registration:

**Pest Control Business (PCB)** - must be the Qualified Applicator License holder

- Valid Picture ID
- Current Qualified Applicator License for the calendar year of registration
- Current State Business License for the calendar year of registration
- Current [Equipment List](#)
- Current Medical Supervision (if you use Organophosphates or Carbamates)
- Fee is \$50.00 per location
- Registering by mail - you **must** include:
  - A letter stating you will not be using Restricted Materials and
  - A completed [PCB County Registration form](#) (PR-PML-059)

**Maintenance Gardeners** - must be the Qualified Applicator Certificate holder

- Valid Picture ID
- Current Qualified Applicator Certificate for the calendar year of registration
- Current State Business License for the calendar year of registration
- Fee is \$25.00

**Pest Control Adviser (PCA)**

- Valid Picture ID
- Current Pest Control Adviser License for the calendar year of registration
- Fee is \$10.00 if Kern County is your home county;
  - Out of County PCAs may register by mail. \$5.00 if you are already registered in another county (include completed [PCA County Registration form](#) PR-PML-091)

**Notice to Structural Pest Control Businesses**

You can now submit monthly summary pesticide use reports (MSPURs) to the Kern County Department of Agriculture online or electronically. See [Electronic and Online Use Report Submission letter](#) for more information.

**Structural Pest Control Businesses - Branch 1** - a responsible person must register in person

- Valid Picture ID
- Current Structural Pest Control Board Company Registration for the calendar year of registration
- Current Operator License for the calendar year of registration
- Fee is \$10.00
- Completed [Registration for Branch 1 – Structural Fumigation form](#) (3 pages).

**Structural Pest Control Businesses - Branch 2 & 3** - may register by mail

- Valid Picture ID
- Current Structural Pest Control Board Company Registration for the calendar year of registration
- Current Operator License for the calendar year of registration
- Fee is \$10.00
- Completed [Structural Pest Control Business / Qualifying Manager Registration Branch 2 & 3 form](#) (2 Pages).

**Agricultural Pilot**

- Valid Picture ID
- Current DPR Agricultural Aircraft Pilot Certificate, FAA Pilot and Medical Certificates for the calendar year of registration
- If you are an apprentice, you must have a journeyman to supervise you
- Fee is \$10.00 if Kern County is your home county;
  - Out of County Pilots may register by mail. \$5.00 if you are already registered in another county (include completed [Pilot County Registration form](#) PR-PML-091)

**Farm Labor Contractor** - must be the license holder - may register by mail

- Current Farm Labor Contractor License with picture **or** letter from Department of Industrial Relations verifying that you are currently licensed for the calendar year of registration with a valid picture ID
- Fee is \$25.00
- If registering by mail you must also include:
  - A copy of a current 2015 registration from another county
  - Completed [Kern County Farm Labor Contractor Registration forms](#) available online.
